- Individual Golf - \$75 plus tax, monthly \$899 Annual**
Individual membership includes: unlimited golf, easy access tee times, golfing & social events, pool, dining & banquet facilities.
- Family Golf - \$92 plus tax, monthly \$1099 Annual**
Family membership includes: unlimited golf, easy access tee times, golfing & social events, pool, dining & banquet facilities.
- Under 40 Individual - \$55 plus tax, monthly \$660 Annual**
Individual membership includes: unlimited golf, easy access tee times, golfing & social events, pool, dining & banquet facilities. For age determinations, one's age on January 1st of the membership year shall apply.
- Under 40 Family - \$70 plus tax, monthly \$840 Annual**
Individual membership includes: unlimited golf, easy access tee times, golfing & social events, pool, dining & banquet facilities. For age determinations, one's age on January 1st of the membership year shall apply. In a family membership, the oldest family member's age shall determine the membership classification.
- Individual Non-Resident \$699 plus tax**
Individual membership includes: unlimited golf, easy access tee times, golfing & social events, pool, dining & banquet facilities. To qualify must reside 20 miles away from Faribault Golf Club.
- Family Non-Resident \$999 plus tax**
Individual membership includes: unlimited golf, easy access tee times, golfing & social events, pool, dining & banquet facilities. To qualify must reside 20 miles away from Faribault Golf Club.
- Junior/Student Membership (23 & under) - \$300 plus tax**
Juniors must follow the Club policies in the membership handbook for playing and practicing times. Junior members are given range membership as part of this membership.
- Pool Membership - \$200 plus tax**
